Haryana Economy: test

1. a)4,92,656.90 crore

The Department of Economic & Statistical Analysis, Haryana (DESA) prepares the estimates of Gross State Domestic Product (GSDP) of the State. As per the Advance Estimates for the year 2015-16, the GSDP of the State at current prices has been recorded as ` 4,92,656.90 crore recording the growth of 11.5 percent over the previous year.

2.a) 3,66,584.10 crore

The GSDP at constant (2011-12) prices for 2014-15 has been estimated as 3,66,584.10 crore as against the Provisional Estimates of ` 3,39,491.35 crore for 2013-14 recording the growth of 8.0 percent.

3. a)7.6 percent

The growth in real Gross State Value Added (GSVA) was recorded as 7.0 percent during the year 2012-13. During 2013-14, the growth in GSVA fell down to 5.5 percent which may be mainly attributed to the low growth (2.8%) recorded in Industry Sector. In spite of negative growth of 0.7 percent recorded in Agriculture & Allied Sector and low growth (5.9%) recorded in Industry Sector, the growth in GSVA in 2014-15 improved to 7.2 percent because of higher growth (11.5%) recorded in Services Sector.

During 2015-16, in spite of low growth of 1.4 percent recorded in Agriculture & Allied Sector, the GSVA is expected to register the growth of 7.6 percent which is mainly due to the higher growth of 9.6 percent and 8.2 percent expected to be achieved in Services and Industry Sectors, respectively

At the beginning year (1969-70) of 4th Five Year Plan, the contribution of Agriculture and Allied Sector (Agriculture, Forestry and Fishing) in the GSDP at constant prices was largest (60.7 percent) followed by Services (21.7 percent) and Industry (17.6 percent) Sectors.

5.a) 51.3 percent

During the period of 11th Five Year Plan and onwards, the pace of structural transformation of State economy remained continued. Consequent upon the robust growth recorded in Services Sector in this period, the share of Services Sector in GSVA further strengthened to 51.3 percent in 2015-16 with the decrease in the share of Agriculture & Allied Sector at 18.2 percent . Thus, the composition of GSDP shows that the share of Agriculture & Allied Sector is continuously declining whereas the share of Services Sector is continuously increasing.

The projected revenue deficit for the fiscal 2016-17 has been put at Rs12280.35 crore while it was projected at Rs9557.52 crore in 2015-16. The fiscal deficit has been put at Rs25115.96 or 2.47 percent of the GSDP while it was projected at 16423.58 crore in the ongoing fiscal year.

Capt Abhimanyu said, "There has been a jump in the state's own taxes as a percentage of the Gross State Domestic Product from 6.3 percent in 2014-15 to 6.9 percent in 2015-16. More impressive is the fact that this ratio has been showing a declining trend from 2011-12 onwards for four years before this turnaround in 2015-16. In 2016-17, we expect this ratio to be around the same level."

Narasimham Working Group during the tenure of Indira Gandhi's government with a view to include rural areas into economic mainstream since that time about 70% of the Indian Population

It borrows from NABARD, State Government etc. It has been advancing loans for various purposes like agriculture, manufacturing, marketing and processing, transport, housing, distribution and stocking etc. It has a staff training college situated at Panchkula.

The Planning Department formulated the State's Plan Budget 2015-16 at ` 24,870.87 crore which includes Central Assistance of ` 5,106.21 crore for Centrally Sponsored Schemes. Social Services have been allocated an outlay of ` 15,183.71 crore (61.05%). Among Social Services, the highest priority has been accorded to the provision of pension for the old, the differently abled, the widows and the destitute as these are the most vulnerable sections of the society and the State owns a moral responsibility towards them. Accordingly, an outlay of ` 3,597.06 crore (14.46%) has been kept for Social Justice & Empowerment. Women and children are the other vulnerable sections which also need the State care. An amount of ` 785.80 crore (3.15%) has been set apart for the Women and Child Development Programmes including Nutrition.

The new berojgari bhatta scheme is announced monetary help will be provided to the unemployed people who are 21 to 35 age and looking for the job. Haryana government starts Berojgari Bhatta scheme on 1 Nov 2016 at its golden jubilee program.

There are two components in new Berojgari Bhatta Haryana. The Berojgari Bhatta will be distributed according the education qualification of the applicants. The government will provide amount of Rs. 900 for the 12th passed students, Rs. 1500 for graduates and 3000 for the post graduate students.

Earlier the Berojgari Bhatta was provided to the post graduate students only but now it will be provided to other applicants also. In old scheme the maximum family income limit was 50,000 Rupees, residential property and commercial finance should not more than Rs. 10 lac and 2 hectares of agriculture field needed but now the applicants have to fill only one requirement that is family income should not more than 3 lac Rupees from all source.

Government Provide Employment in Govt Sectors, Boards and Municipals

The government of Haryana will provide Rs. 6,000 for 100 hours work in the different sections directed by the government like boards, municipals and in Registered societies. There is also a proposal for the applicants that they can take the benefits from Haryana industrial and commercial department according to their requirement for private firms or industry.

Under educated handicapped pension scheme, educated people with disabilities having not less than 70% disability and educational qualification of middle, metric and above level or diploma holder are provided un-employment allowance from the date of their registration in the employment exchanges for 6 years period.

Rate of Scholarship as per the Class

Here are the details of the scholarship provided under educated handicapped pension scheme.

- 1st to 5th class Rs. 400 per month
- 6th to 9th class Rs. 500/month
- 10th to 12th class Rs. 750/month
- Diploma holder Rs. 1000/month
- Graduate Rs. 1500/month
- Post graduate Rs. 2000/month

Apart from educated handicapped pension scheme, schemes like scholarship for these students, unemployment allowance to educated students, grant-in-aid to voluntary organizations engaged in welfare of physically challenged and financial assistance to non school going disabled students are being carried out by the state government.

The state government will launch a Saksham portal of Saksham Shikshit Yuva Sammanit Hua yojana under which Rs 9000 will be given to the post graduates unemployed youth in lieu of 100 hours of work per month.

The main objective of this scheme is to provide the opportunities to the unemployed youths to make their future strong. 1100 beneficiaries are taking the benefit of Unemployment Allowance under this scheme with employment exchange across the state.

The state government has decided to invest Rs 324 crore for this scheme for the post graduates unemployed candidates of Haryana. To take the benefit of this scheme the candidate should be the permanent resident of Haryana and he should be post graduated from university of Delhi, Chandigarh or Haryana. In the state there are approximate 8 Lac literate candidates who have registered themselves under the various schemes run by the government.

Under this scheme there is the involvement of the private sectors and a web portal has been prepared which will be launched soon. To be register under this scheme the family income of the candidates should not exceed Rs 3 Lac per annum from all the sources of income and the candidate should not join any company.
