CORRIGENDUM

This corrigendum is in continuation of Advertisement No. 3 of 2018 published on 02.08.2018 for the posts of HCS (Ex. Br.) & other Allied Services – 2017. As per the orders issued by the Government of Haryana vide Endrst No. 66/24/2015-2SIII dated 30.01.2019, the candidates who have attained the age of 21 years as on 01.08.2018 are also to be considered eligible for aforesaid posts. Accordingly, the Commission invites online application forms from eligible candidates who had not applied earlier for the said posts.

Further, in view of the orders dated 11.12.2018 passed by the Hon'ble Punjab & Haryana High Court in CWP No. 22328 of 2018, Clause 3 of the Sports Policy (issued vide Notification No. 4/40/2017- 4SYA dated 25.05.2018) has been amended by the Government vide Notification No. 4/40/2017- 4SYA dated 15.11.2018 making those Sports persons eligible for the posts reserved for ESP of Haryana who are Domicile./ Residents of Haryana irrespective of the fact that they have represented UTs or other States. So, the candidates who have not applied earlier can apply now if they fulfill the eligibility criteria in view of the Sports Policy dated 25.05.2018 amended vide notification dated 15.11.2018. (Policy dated 25.05.2018 & 15.11.2018 are available on Commission's website alongwith "Instructions to Candidates")


The candidates who are applying now against this corrigendum should not be less than 21 years and not more than 42 years (27 years for the posts of DSP) on or before 01.08.2018. The eligibility with regard to qualification etc will be determined as on 15.02.2019 (closing date) whereas other terms & eligibility condition as mentioned in the advertisement will remain unchanged. The candidates can now apply online from 07.02.2019 to 15.02.2019 (12:00 midnight) and fees can be deposited upto 15.02.2019 (12:00 midnight) through the link given on the online portal.

The candidates who had applied earlier against Advt No- 3/2018 need not apply again as their earlier application forms will be considered, if they fulfill all the eligibility conditions as per provision of above Advt No. 3/2018 (i.e. age will be determined as on 01.01.2018 & other eligibility regarding qualification etc will be determined as on 14.09.2018).

The application form alongwith prescribed fees submitted through online portal to the Commission will only be taken into consideration. The offline application form or the application form without fees will not be taken into consideration by the Commission. So, the candidates are advised to submit their online application form and deposit the fees well in time carefully to avoid rejection. No refund of fees will be made by the Commission in any case.

Note :- It is for the information of all the candidates including the candidates who have applied earlier that the benefit of age relaxation will be given to the candidates of reserved categories of Haryana only for the posts which are reserved for their categories (except PH Category candidates of Haryana).
